#### TERMS AND CONDITIONS

1. Your service will be liable to be terminated with a Notice of 14 days. In Lieu of the Notice of termination of service it should be permissible on the part of Railway Administration to terminate your service by paying you the pay and allowances for the period of notice.
2. No Notice of termination of your service is required if such termination is to the expiry of the sanction to the post which you had or the expiry of vacancy. Due to compulsory retirement, due to mental or physical incapacity or to removal or dismissal as a disciplinary measure against you after the compliance with the provision of clause (2) or Article 311 of the constitution of India.
3. No notice of termination is required where you are deemed to have resigned your appointment and ceased to be in employment if you remain absent or EOL beyond the limit of 05 (Five) years.
4. It must be clearly understood that you are guided by the New Pension Scheme effective from 01/01/2004 and not by Railway servants Pension rules 1993 in terms of Railway Board's L/No F/E/I/III/2003/PEN-1/24 dated 31.12.2003 and No. 2004 - AC-2-I/21/III dated 19.02.2004.
5. You will not be eligible for any benefit except those admissible to temporary employees under rules in force time to time.
6. Further more, your appointment to the Railway servant will be governed by provisions of the Indian Railway Cases and their extent orders as amended / issued by the Government of India, Ministry of Railways from time to time.
7. Railway service conduct rule 1966 and D&AR 1968 will be applicable to you.
