## Concept Note

In India, Human Rights Day holds significance as it marks the commitment to promoting and safeguarding the rights of all irrespective of racial, religious, linguistic, sexual, or any other identity. It also ushers hope for the inclusion of minority identities for a more inclusive and egalitarian society.
